Probate Court is an administrative court that among many duties oversees the recording of deeds and mortgages, articles of incorporation, powers of attorney, and the issuance marriage licenses and notary certificates. The court processes wills and administrations, guardianships and conservatorships, adoptions, handles issues of imminent domain and oversees the involuntary mental health commitment process. The Probate Judge also serves as Madison County's chief election official. Not to minimize the importance of the role, but a relatively small amount of time is spent "on the bench" as you might envision – it is spent overseeing multiple mandated processes, interacting with state, county and municipal government and providing direct service to the public and the legal, banking, building and real estate industries. Each citizen of Madison County will conduct business with the Probate Court at some point.

- Ensure secure, transparent, and efficient countywide elections

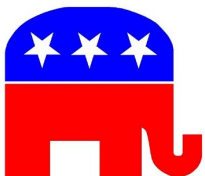

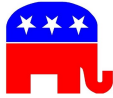

- Hours spent manning the headquarters of similar activities.



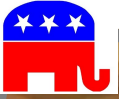

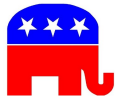
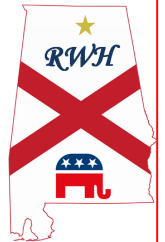
